



**2026/27 Terms of Reference for Committees of the Board of Directors**

- Committee **members are subject to approval** by the Board.
- Committees are **assigned Strategic Priorities** by the Board.
- Committees **must report progress** to the Board when milestones reached, the Board requests, or at least annually.
- Committees shall have **at least one Board member** serving as Chair or Co-Chair.
- **External communication** of new Committee/VEHS positions **subject to prior Board approval**.
- Committees are to produce brief **action plans** or elaborated terms of reference, as appropriate, for **information** to the Board and to **guide** Committee work.
- Committees may propose **budgets** for Board approval, or seek approval for each expenditure.
- The Board may **refer additional issues** or tasks to Committees throughout the year.
- Committees to be **consensus-seeking**; if disagreements are unresolvable, committees are to report the different members' views to the Board for decision as and if necessary.
